

ELECTION LEGAL NOTICE
NOVEMBER 8, 2016

To the Electors of Larimer County:

Pursuant to Colorado Revised Statutes, Section 1-5-205, notice is hereby given that a General Election will be held on Tuesday, November 8, 2016, between the hours of 7 AM and 7 PM.

The election will be conducted as a mail ballot election. A mail ballot, return envelope, secrecy sleeve and voting instructions will be mailed to every active voter in Larimer County during the week of October 17, 2016. You may return your voted ballot by mail with adequate postage (postage is 68 cents) or you may hand deliver your ballot to a Designated 24 Hour Ballot Drop Box, Ballot Drop-off Location or a Voter Service and Polling Center.

Voters may drop off their voted ballots 24 hours a day at the following ballot drop box locations. Ballots will be accepted in these boxes until 7 PM Election Night:
